Especially those near to water bodies?</li> <li>• Proposals within 200m of rivers, streams, canals, lakes or other aquatic habitats?</li> <li>• Buildings and walls with thick, dense ivy covering?</li> <li>• Tall walls (2m+) with crevices?</li> <li>• Proposed tree work (felling/lopping) old/veteran trees</li> </ul>
