

# Neighbourhood Area Designation: The Giddings, Winwick and Hamerton



An application for designation of a neighbourhood area was received from Great & Little Gidding Parish Council, Hamerton and Steeple Gidding Parish Meeting and Winwick Parish Meeting by Huntingdonshire District Council on 25 November 2022.

The proposal was subject to a formal 6 week consultation between 1 February 2023 and 15 March 2023 in accordance with Regulation 6 of the Neighbourhood Planning (General) Regulations 2012 as amended. Responses to the Consultation can be found on the Council's [online consultation portal](#).

In accordance with regulation 5 of the Neighbourhood Planning (General) Regulations 2012 as amended, Huntingdonshire District Council is satisfied that the application includes:

- a. a map which identifies the area to which the area application relates;
- b. a statement explaining why this area is considered appropriate to be designated as a neighbourhood area; and
- c. a statement that the organisation or body making the area application is a relevant body for the purposes of section 61G of the 1990 Act.

As specified by regulation 6A (2) (c) (Prescribed date for determination of an area application) Huntingdonshire District Council must determine the application within 13 weeks from the date immediately following the publication of the application. Following review of the representations received to the consultation, relevant legislation and guidance Huntingdonshire District Council hereby designates The Giddings, Winwick and Hamerton as a neighbourhood area.
