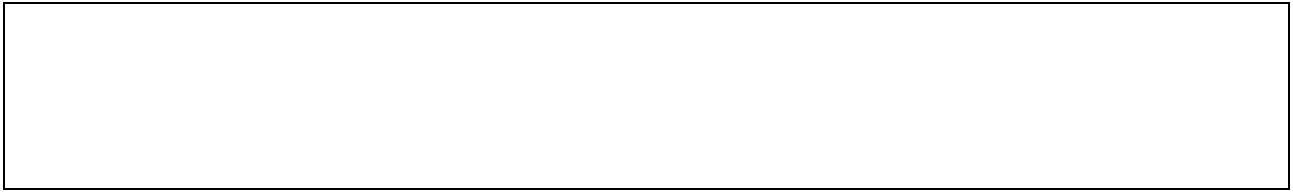

## Notes
